SCHOLARSHIP PROGRAM GUIDELINES AND APPLICATION

The North Central Branch of the Texas Chapter of the American Public Works Association Scholarship Program is designed to assist those individuals who are pursuing a career in the Public Works field. The Association believes that improving one's knowledge in the Public Works field encompasses disciplines from inspection, construction, engineering or public administration, as well as, continuing education for career enhancement. This assistance in education promotes and ensures a continuation of the high level of skill, talent and professionalism that is the pride of every member.

Traditionally, the American Public Works Association and its Chapters have strived for the advancement and continued development of all of the various components that make up the Public Works family. It is incumbent upon the membership of the North Central Branch to lend a helping hand to those who have chosen the public services field as their career. The Scholarship Program is an integral part of achieving this goal.

The North Central Texas Branch Chapter Scholarship Program offers two (2) student categories in which scholarships may be awarded:

- 1. <u>UNDERGRADUATE PROGRAM</u>: Awarded to a college student who has earned at least 60 credit hours, at the time of the application, through enrollment at any accredited college or university in the State of Texas, seeking an undergraduate degree in a field related to Public Works Engineering or Public Administration. The student must also have at least a GPA of 2.5 on a 4.0 system and demonstrate an interest in a public works career.
- 2. <u>GRADUATE PROGRAM</u>: Awarded to a person who has earned at least six credit hours and is pursuing an advanced degree in Public Works Engineering Management or Public Works Administration at any accredited college or university in the State of Texas.

All awards shall be provided to applicants for upcoming expenditures related to tuition or educational expenses incurred in the pursuit of additional education. Funds will not be provided for the payment of an applicant's expenditures incurred prior to the application deadline. The TX-APWA North Central Branch reserves the right to refuse payment in the event that this situation should arise.

ANTICIPATED AWARDS

The actual number of scholarships awarded each year is contingent upon available funds and will be determined by the North Central Texas Branch Board of Directors.

Undergraduate and Graduate Programs awarded scholarship funds shall be used for tuition/books for classes in subjects related to public works at any accredited school. The TX-APWA North Central Branch reserves the right to refuse payment for expenditures incurred prior to the application deadline.

APPLICATION PROCEDURE

Undergraduate and Graduate Scholarship applicants shall complete the attached Scholarship Application Form and return all necessary information postmarked by **May 31, 2024.** The following schedule provides the applicant with information regarding deadlines and notifications.

May 31 Complete applications and required information due by email

Early June Scholarship Committee will acknowledge receipt of applications by email

July Committee will present recommendation to the NCT Board of Directors,

and winners will be notified by email

Fall Student scholarship recipients will be invited to attend the North Central

Texas Branch One Day Seminar in the fall to receive recognition of the

award

SELECTION

Undergraduate and Graduate Program applications will be evaluated by the Scholarship Committee based on the applicants' submittal. The Scholarship Committee will recommend award recipients to the North Central Texas Branch Executive Committee who will make the final decision.

Scholarship Program recipients will be encouraged to attend a Fall meeting of the North Central Texas Branch to accept the award and receive recognition. Should a recipient not be able to appear to receive the scholarship, it will be mailed.

- 4. In a maximum of 500 words, prepare a short essay describing a current issue facing the Public Works community.
- 5. Provide a list of 3 character references name, title, relationship to applicant, email address and phone number.
